5.1 LED Street Lighting Standards

Morrie Zuckerman conducted a presentation on the best practices of LED streetlighting with an emphasis on municipalities. He provided a general overview of LED street lights and the advantages and disadvantages compared to other conventional light sources. There was also discussion on the popular retrofitted fixtures along with an overview of common pitfalls associated with retrofits. Mr. Zuckerman also explained various testing mechanisms for LED lighting including the LM-79 and LM-80.
